







# PUBLIC NOTICE

For the selection of 1 local coordinator, 1 communication expert, 2 agronomists and 1 agricultural worker for the project "Pro.Tec.T - Product Technologies and Traceability in Albania" AID 10694

## 1. DESCRIPTION AND PURPOSE

The aim of the project "Product Technologies and Traceability in Albania - Pro.Tec.T" is to support the general development of public and private food safety in Albania, improving the competitiveness of some food supply chains in the regions of Elbasan and Korçë and acting on the value chain and territorial marketing.

The local counterpart for this project, co-financed by AICS (Agenzia Italiana Cooperazione allo Sviluppo - Italian Agency for Development Cooperation), is the Albanian Ministry of Agriculture and Rural Development.

The Umbria Regional Administration is the executing body of the project.

For the implementation of the project, the Umbria Region will use the services of Sviluppumbria S.p.A. - Società Regionale per lo Sviluppo Economico dell'Umbria and of 3A - Parco Tecnologico Agroalimentare dell'Umbria S.c.a.r.l. Both entities are in-house providing companies of the same Regional Administration in their respective specialization field, as identified and regulated by a partnership agreement entered into on 5 September 2018.

In particular, Sviluppumbria S.p.A. will oversee the general coordination of the project management system.

In order to carry out this activity, in compliance with the provisions of Article 7, paragraph 6 of Legislative Decree 165/2001, Sviluppumbria S.p.A., may also seek the collaboration of professionals outside its structure, whenever these professional positions cannot be filled internally. For these reasons, Sviluppumbria S.p.A. is issuing this Notice to activate a procedure for the selection of the following figures:

- 1 Local Coordinator,
- 1 Communication Expert,
- 2 Agronomy Experts in the areas of Elbasan and Korçë respectively
- 1 Agricultural Worker.

The selected candidates will compose the local staff in Albania.

## PROJECT AREAS: AGRICULTURE AND LOCAL DEVELOPMENT

The general objective of the project is to support the general development of public and private food safety in Albania.

The specific objective of the project is to improve the competitiveness of production chains by acting on the value chain and territorial marketing. The project strategy will follow two strategic lines:

- Improvement of the value chain;
- Integrated promotion and territorial marketing approach.









# RECRUITEMENT OF 1 LOCAL COORDINATOR

# The Local Coordinator shall:

- Support the Italian Project Coordinator;
- Be responsible for and coordinate the local project staff, composed of 1 Local Coordinator, 2 Agronomy Experts, 1 Expert in communication and information and 1 Agricultural Worker;
- Be responsible for the execution of all project activities in Albania according to the prescriptions of the attached Logical Framework, project schedule and POG. This responsibility will be shared with the Italian Project Coordinator, to whom the Coordinator will report from time to time according to the procedures established by the Financing Body, Sviluppumbria and the reference regulations;
- Seek support from the financial managers and the secretary of the local office that will be made available by the economic operator selected by Sviluppumbria.

## Specifically:

# The Local Coordinator will be directly responsible, together with the Italian Project Coordinator, for the following project activities in Albania:

- Provision of equipment to improve the quality of supply chain(s), to be identified in the areas of Korçë and Elbasan;
- On-the-job training to improve the quality of identified supply chains;
- Implementation of a pilot project for the certification of 10 companies/products in the agrifood sector, according to ISO 22000/2005, ISO 22005/2007 (Management systems for food safety and traceability in agrifood chains) and/or other voluntary standards such as "Made with Italy";
- Meetings with beneficiaries and possible stakeholders and organization of two workshops per area on the LEADER/Community-Led Local Development approach;
- Territorial animation aimed at creating two Local Action Groups (LAG);
- Organization of four workshops on LAG management and on opportunities for access to IPA/IPARD funding and follow-up;
- Participation in the transnational part of LEADER+ Umbrian programs;
- Establishment of three producer and/or transformer associations;
- Provision of technical and administrative documentation for the establishment of three producer and/or transformer associations;
- Drafting of production specifications, and
- Transmission to the Albanian Ministry of Agriculture of the documentation required for the submission of applications for product registration to the EU.

# With regard to the activities of project partners, the Local Coordinator will be responsible for:

• Maintaining constant relations with the local counterpart, beneficiaries, the AICS in Tirana, cooperation agencies, local institutions and other players involved in the project;









- Supporting the field activities of Italian partners, the Executive Secretariat and all Italian experts involved in the project, also based on Albanian-Italian translations and interpreting, and
- Representing the partnership in Albania and in particular in Tirana and the two project areas (Korçë and Elbasan) in respect of project issues.

# With regard to cross-functional activities, the Local Coordinator will be responsible for:

- Arranging monthly coordination and monitoring meetings (including with distance communication means) with the Italian Project Coordinator and the Italian supervision experts, in order to provide updates on the progress made, highlight criticalities and deviations from the expected results, identify potential risks and suggest possible solutions;
- Ensuring adequate monitoring of on-the-spot activities as set out in the project;
- Collaborating with the Italian Project Coordinator and Sviluppumbria administrative offices on matters concerning the planning and management of activities;
- Collaborating with the local Expert in communication, information and sensitization to ensure adequate project visibility as laid down in the "Guidelines on Visibility" issued by the Italian Agency for Development Cooperation in Tirana;
- Preparing a draft of project narrative and accounting documents (Descriptive and Accounting Reports, Operation Plans);
- Cooperating with the financial managers and the secretary in the local office to ensure proper keeping of accounting documents and logistical organization of activities;
- Supervising the management of supplies, supporting the Italian partners in the handling of procedures for the purchase of goods and equipment and taking care that these are finally transferred to local counterparts, and
- Coordinating the work of the two local Agronomists and the Agricultural Worker in Albania.

# General minimum requirements for participating in the selection procedure

Candidates for the position of Local Coordinator must meet the following general minimum requirements in order to be eligible for selection:

- b) To enjoy full civil and political rights (not being excluded from the active political electorate);

- Excellent knowledge of spoken and written Albanian;
- Excellent knowledge of computer programs for word processing and calculation (e.g. Windows Office, Open Office, etc.);
- Excellent knowledge of planning, management and administration tools of Project Cycle Management (Logical Frame Work).

## Preferential requirements:

- Past work experience in local and rural economic development fields;
- Past work experience in the regions of Elbasan and Korçë in the fields covered by this project;
- Past study or work experience in Italy or with Italian partners.

In order to be eligible for selection, candidates must meet the minimum (general and specific) requirements for participation when they submit their application.

# WORKLOAD AND TYPE OF WORK RELATIONSHIP

Full-time work. No subordinate employment contract will be established.

# PLACE OF WORK

The candidate will work in Albania. A workstation will be set up in Tirana in the offices of the Albanian Ministry of Agriculture and Rural Development, whereby the candidate will carry out institutional connection activities with the local counterpart. He/she will pay frequent visits to the structures involved in the project areas, where he/she will coordinate the work of the Albanian staff, using – among others – the support of the local office and its administrative staff (financial manager and secretary).









## REMUNERATION

Remuneration will amount to 1,800.00 EUR per month, inclusive of all charges and costs, including all travel costs connected with his/her task, and including withholding taxes and social security and insurance contributions according to law at Sviluppumbria's or the Coordinator's charge.

Sviluppumbria reserves the right at any time to cancel this assignment for serious breaches.

## TERM

This collaboration will start from the signing of the work assignment up to 30 May 2019, unless specified otherwise, based on the duration of the project execution.

# 2. RECRUITEMENT OF 1 EXPERT IN LOCAL COMMUNICATION, INFORMATION AND SENSITIZATION

The Local Communication Expert shall:

- Support the Local Project Coordinator, and
- Liaise with the Italian Project Coordinator and the Italian communication expert for the implementation of project communication, information and sensitization in Albania.

Specifically, the Local Communication Expert shall:

- Draw up a project communication plan with the aim of informing and raising awareness among companies and target groups, with special regard to the following activities:
  - Implementation of a pilot project for the certification of 10 companies / products in the food industry according to ISO 22000/2005, ISO 22005/2007 (Management systems for food safety and traceability in food supply chains) and/or other voluntary standards such as "Made with Italy";
  - Rural development in the Elbasan and Korçë areas to be supported by the Leader approach, and
  - Promotion of three agrifood products through the preparation of a Community dossier for obtaining the DOP/IGP status.
- Draw up the graphics and contents of project communication and information material in English and Albanian (e.g. invitations, e-vite templates, banners, brochures, newsletters, press releases);
- Supervise the project press office;
- Facilitate awareness raising activities in the area;
- Encourage the involvement and sensitization of beneficiaries and public and private stakeholders on specific project activities and issues, including by organizing press conferences and theme meetings;
- Promote the project dissemination through the exploitation of results, best practices and execution phases, not only locally or in Italy, but also internationally through specialized channels in project issues;









- Promote the establishment of relationships and collaborations with new communication and dissemination channels;
- Encourage communication by also viewing marketing as a tool for the sustainability of project activities;
- Manage the project's social channels, and
- Systematize the experiences of the project.

- Excellent communication and relationship skills with partners, beneficiaries, donors and local institutions;









- Albanian as mother language and excellent mastery of written and spoken English, and
- Ability to manage project communications using an appropriate and specific language for the subjects in question.

# Preferential requirements:

• Past work experience in international cooperation projects.

# WORKLOAD AND TYPE OF WORK RELATIONSHIP

Workload will be proportional to the activities required. No subordinate employment contract will be established.

# PLACE OF WORK

The candidate will work in Albania. A workstation will be set up in Tirana in the offices of the Albanian Ministry of Agriculture and Rural Development, whereby the candidate will carry out institutional connection activities with the local counterpart. He/she will pay frequent visits to the structures involved in the project areas (Elbasan and Korçë) where he/she will carry out communication tasks.

## REMUNERATION

Remuneration will amount to 600,00 EUR per month, inclusive of all charges and costs, including all travel costs connected with his/her task, and including withholding taxes and social security and insurance contributions according to law at Sviluppumbria's or the Expert's charge.

Sviluppumbria reserves the right at any time to cancel this assignment for serious breaches.

## TERM

This collaboration will start from the signing of the work assignment to 30 May 2019, unless specified otherwise, based on the duration of the project execution.

# 3. RECTRUITEMENT OF 2 AGRONOMY EXPERTS

## The 2 selected agronomists shall:

- Coordinate the working activities to be carried out and will be localized respectively in Korçë and in Elbasan. The will perform their task under the supervision of the Local Coordinator and in close collaboration with Italian experts.

## Specifically:

The 2 agronomists (each in their respective geographical area) shall:

• Provide coordinating support to the working activities of the pilot project aimed at the certification of 10 companies/products coming from the supply chains that will be identified in the areas of Elbasan and Korçë;









- Provide coordinating support to the working activities for territorial animation and rural development in the Elbasan and Korçë areas, taking the LEADER/Community-Led Local Development approach into account;
- Provide coordinating support to the working activities for the promotion of three typical food products, to be identified in the areas of Elbasan and Korçë, with the preparation of EU dossiers for obtaining the DOP / PGI status;
- Involve beneficiaries, producer groups, individual producers and individual companies in specific project activities, in particular with reference to the good practices and technologies that will be introduced to increase the competitiveness of supply chains;
- Draft studies, analyses and technical reports;
- Facilitate the provision of documents and data to Italian experts, as required for certification and traceability purposes and for the definition of product specifications, and
- Supervise the performance of the Agricultural Worker, who will be involved in activities aimed at increasing the competitiveness of supply chains.

# General minimum conditions for participation in the selection procedure

Candidates for the position of **Agronomist** must meet the following general minimum requirements to be eligible for selection:

- a) To be a resident of Albania;
- b) To enjoy full civil and political rights (not being excluded from the active political electorate);
- c) To have reached the age of majority and not to be over 64 years of age on the date of Notice deadline and, if so required by applicable laws, to have performed the compulsory military service, if any;

- Experience as a field technician;
- Excellent knowledge of the production facilities in Elbasan or Korçë areas;
- Familiarity with quantitative and qualitative analysis, as well as with the drafting of cultivation and economic plans related to crops;
- Albanian as mother language;
- Knowledge of the Italian language.

# Preferential requirements:

- To be a resident of Korçë or Elbasan;
- To have knowledge of the production facilities in both Elbasan and Korçë;
- To be familiar with the LEADER/Community-Led Local Development approach;
- To have experience in public-private partnerships in the field of rural development.

# WORKLOAD AND TYPE OF WORK RELATIONSHIP

Full-time work. No subordinate employment contract will be established.

## PLACE OF WORK

Work will be divided between the 2 Agronomists on a territorial basis: 1 expert will be devoted to Korçë and 1 expert to Elbasan. They will pay visits to the project structures and frequent coordination visits to Tirana.

## REMUNERATION

Remuneration will amount to 1,250.00 EUR per month, inclusive of all charges and costs, including all travel costs connected with his/her task, and including withholding taxes and social security and insurance contributions according to law at Sviluppumbria's or the Agronomist's charge.

Sviluppumbria reserves the right at any time to cancel this assignment for serious reasons, having heard the opinion of the Umbrian Regional Administration.

## TERM

This collaboration will start from the signing of the work assignment to 30 May 2019, unless specified otherwise, based on the duration of the project execution.

# 4. RECRUITEMENT OF 1 AGRICULTURAL WORKER

The Agricultural Worker will work in Korçë and Elbasan under the supervision of the Local Coordinator, following the indications of the Agronomy Experts and in close collaboration with Italian experts.









In particular, he/she will take care of the activities aimed at increasing the competitiveness of production chains through the introduction of good practices and technologies.

Candidates for the post of agricultural worker must meet the following general minimum requirements in order to be eligible for selection:

- a. To be a resident of Albania;
- b. To enjoy full civil and political rights (not being excluded from the active political electorate);
- c. To have reached the age of majority and not to be over 64 years of age on the date of Notice deadline and, if so required by applicable laws, to have performed the compulsory military service, if any;
- d. Not to have been subject, in Italy or Albania, to:
  - Final convictions or sentences, or prevention or protection measures, or criminal and/or administrative proceedings that may be regarded as hindrance to the establishment and/or maintenance of a civil servant employment relationship;
  - Final convictions or sentences, or prevention or protection measures, or criminal and/or administrative proceedings that may hinder the establishment and/or maintenance of a civil servant employment relationship;

The place of work is in Albania and more precisely in the area of Elbasan or Korçë. Frequent visits will be paid to the structures involved in project activities and to Tirana.

## REMUNERATION

Remuneration will amount to 450,00 EUR per month, inclusive of all charges and costs, including all travel costs connected with his/her task, and including withholding taxes and social security and insurance contributions according to law at Sviluppumbria's or the Agricultural Worker's charge.

Sviluppumbria reserves the right at any time to cancel this assignment for serious reasons, having heard the opinion of the Umbrian Regional Administration.

## TERM

This collaboration will last 5 months, unless specified otherwise based on the duration of the project execution.









# 5. APPLICATION AND DEADLINE FOR SUBMISSION

In order to be eligible to participate in the selection process, the candidates must draw up their application using Annex A) to this Notice, otherwise their application will not be admissible.

In their application, all candidates must declare under their own responsibility:

- 1. Their surname, first name, tax code, date and place of birth and place of residence (and address);
- 2. To be a resident of Albania;
- 3. The municipality in whose electoral rolls they are registered or the reasons for their non-inclusion in or deletion from the electoral rolls;
- 4. To enjoy full civil and political rights or the reasons for their non-enjoyment;
- 5. To have reached the age of majority and not to have exceeded 64 years of age, and to have fulfilled any obligations on compulsory military service, if and as provided for by current laws;
- 6. Not to have been subject, either in Italy or Albania, to:
  - Final convictions or sentences, or prevention or protection measures, or criminal and/or administrative proceedings that may be regarded as hindrance to the establishment and/or maintenance of a civil servant employment relationship;
  - Final convictions or sentences, or prevention or protection measures, or criminal and/or administrative proceedings that may hinder the establishment and/or maintenance of a civil servant employment relationship;
- 7. Not to be have ongoing prosecutions in place, either in Italy or Albania, restricting their freedom of movement and travel to or from either countries;
- 8. To be physically fit for the position to be filled and the tasks to be performed;
- 9. Their educational qualification, with the date and university where it was obtained.

The application form shall be written in Italian and must bear the candidate's signature. No authentication will be required. All unsigned applications will be excluded from selection. False or incorrect statements will result in the candidate's exclusion from the procedure or termination of the work relationship, once established.

Candidates shall attach the following to their application, on penalty of rejection:

- 1. Curriculum Vitae in European format, drawn up in Italian and signed in original on each page by the candidate, containing:
  - A detailed description of all work periods and employers, in the fields set out in **Specific minimum requirements Professional experience and knowledge**;
  - A detailed description of past experiences where candidates have gained knowledge of Albanian institutions and of Elbasan and Korçë regions;
  - Any qualifications/certificates, attesting to the candidate's excellent knowledge of the languages required;
  - Any titles/certificates, attesting to the excellent knowledge of computer programs for word processing and calculation, and
- 2. Copy of the applicant's current identity document.









The original copies of applications must be sent to the offices of Sviluppumbria S.p.A., via Don Bosco, 11, 06124 Perugia (ITALY) by express courier, or by registered letter with return receipt or to the following certified (PEC) e-mail address <u>sviluppumbria@legalmail.it</u> within 27<sup>st</sup> December 2018.

Compliance with the above deadline will be proven by the date and number of the entry protocol affixed by Sviluppumbria S.p.A.

All applications received after the deadline will automatically be rejected.

Candidates shall assume all risks with regard to the submission of their application within the specified deadline.

# 6. EVALUATION OF APPLICATIONS AND ASSIGNMENT OF POSITIONS

#### Eligibility assessment:

A Committee composed of officials from Sviluppumbria, Parco 3A, the Umbrian Regional Administration and AICS will check whether candidates meet the general minimum requirements from their application and attached documentation, and will decide on their admission to or rejection from the selection.

Candidates may be excluded from the selection because of:

- 1. Incomplete documentation attached to the application;
- 2. No signature at the bottom of the application;
- 3. Incompliance with the general minimum requirements of this Notice, or
- 4. Submission of the application after the deadline set out in this Notice.

#### Merits assessment:

The Committee will verify whether candidates meet the specific minimum requisites set out in this Notice.
