#### Article 1 Subject

- 1.1 The subject of the contract shall be the supply, delivery, unloading, installation, commissioning, maintenance, after-sales service, of the following supplies:
  - 1. Lot 02: laboratory furnishing
  - 2. Lot 03: Laboratory equipment

The general description of the supplies, including quantities are as follows:

- The place of acceptance of the supplies shall be microbiology laboratory of UCCK Pristine within the infectious disease clinic, the time limits for delivery of each Lot shall be (delivered and installed) within 45 calendar days calculated from the date of the commencement order, and according to the approved activity plan, and the Incoterm applicable shall be CIP<sup>1</sup>. The implementation period of tasks shall run from the date of the notification of the commencing order to the date of the provisional acceptance.
- 1.2 The Contractor shall comply strictly with the terms of the Special Conditions and the technical annex
- 1.3 The supplies which form the subject of the contract must be accompanied by the accessories / consumables necessary for using the goods as specified in the Instructions to Tenderers.
